#### INTRODUCTION

The Alaska Workers' Compensation Appeals Commission (Commission) is charged with providing fair, prompt, and thoughtful adjudication of appeals from Alaska Workers' decisions by the Compensation Board (Board). An appeal the Commission is а formal administrative appeal and appeal decisions must be published. The Commission is committed to ensuring that "hearings in workers' compensation cases shall be impartial and fair to all parties and that all parties shall be afforded due process and an opportunity to be heard and for their arguments and evidence to be fairly considered." AS 23.30.001(4).

Figure 1 in the next column illustrates the place of the Commission in the workers' compensation adjudication system.

The Commission Chair has certain duties prescribed by law. One of the Chair's duties is to make available to the public, and to file with the office of the lieutenant governor, a report regarding the Commission's activity for the prior calendar year, including data regarding time periods between initial receipt and final decisions on appeals, no later than March 15 of each year. This report is filed to satisfy that duty.

#### Figure 1

Under workers' compensation law, the **Alaska Supreme Court** hears appeals from Commission decisions. The Court decides all questions of law, including constitutionality of statutes and the validity and constitutionality of regulations.

Workers' Compensation Alaska **Appeals Commission** hears appeals from Board decisions. There are five Commissioners: two who represent employees, two who represent employers, and the Chair, who is an attorney. An appeal must be heard by one employee Commissioner, one employer Commissioner, and the Chair. Commission decisions bind the Commission itself and all Board panels to a uniform interpretation of workers' compensation law. The Commission must follow Alaska Supreme Court rulings. Appeals are decided on the Board record and arguments presented by the parties. Commissioners use independent judgment on law and procedure, but do not reweigh facts. The Commission is in the Department of Labor and Workforce Development, but is independent of the Division of Workers' Compensation.

The Division of Workers' Compensation offices in Anchorage, Fairbanks, and Juneau, where parties can obtain information, file claims or and attend petitions. The Division hearings. collects data, enforces reporting, reviews selfinsurance certificates, and manages the Workers' Compensation Benefits Guarantv Fund. the Second Injury Fund, and the Fishermen's Fund. The Division also provides administrative support to Division sections, the Board. and Commission.

The hearing officers, prehearing officers, and clerks of the *Adjudications Section* assist the Board to hear, mediate, and decide cases.

The Special Investigations Unit investigates and prosecutes fraud and uninsured employers before the Board.

The *Director* may intervene in appeals.

The Alaska Workers' Compensation Board hears claims and petitions by injured workers, employers, and Division investigators. conduct The panels hearings and approve settlements. The Board consists of nine industry members, nine labor members, and the Commissioner of the Department of Labor. who is the Chair. Board members are appointed to three-year terms. The Board hears cases in three-member panels (one labor member, one industry member, and one hearing officer), but may hear a case with a auorum of two (a representative member and a hearing officer). Each Board panel is independent, but must follow Commission and Alaska Supreme Court rulings. The Board approves regulations adopted by the Division.

#### **COMMISSION MEMBERS**

The Commission consists of five members: two who represent employees, two who represent employers, and the Chair. Each representative member must have at least 18 months of experience as a Board member. The Chair must be an attorney who has engaged in the active practice of law for at least five years in Alaska with experience in workers' compensation law in this state.

The Chief Administrative Law Judge in the Office of Administrative Hearings announces and reviews the applications for each vacancy on the Commission and forwards a list of qualified nominees to the Governor for appointment. The Alaska State Legislature must confirm appointees.

The Commissioners' five-year terms are staggered so a seat on the Commission falls vacant every year. Because every appeal is heard by a full, balanced panel, and a panelist may not hear a case if there is a conflict of interest, avoiding vacancies is a concern of the Commission.

The members of the Commission during 2017 were:

Deirdre D. Ford, Chair, of Anchorage, was appointed Chair by Governor Bill Walker and took office on October 31, 2016. Prior to her appointment, Ms. Ford was retired from the practice of law. From March 2009 to July 2012, Ms. Ford was a Hearing Officer with the Board in Anchorage. From June 1985 through February 2009, Ms. Ford practiced law with Delisio Moran Geraghty & Zobel, with an emphasis in Workers' Compensation law, primarily representing employers. She received her J.D. cum laude from the

University of San Francisco, School of Law in 1984, her M.A. in Political Science from the University of Illinois Chicago in 1973, her M.L.S. in Library Science from the University of California Berkeley, and her B.A. in Political Science from Whittier College in 1963. Her term expires on March 1, 2020.

Philip E. Ulmer, employer an representative, of Eagle River, is a Certified Workers' Compensation Professional employed currently Director of Safety and Risk Management for GCI. He is a previous national president of the American Society of Safety Engineers and of the National Institute for Engineering Ethics, and a 1994 Engineer of the Year finalist with the Alaska Society of Professional Engineers. He served as a member for industry on He was appointed by the Board. Governor Frank Murkowski to a four-year term as Commissioner in November 2005, reappointed by Governor Sarah Palin to a five-year term in March 2009, and reappointed by Governor Sean Parnell to a five-year term in March 2014. His term expires on March 1, 2019.

James N. Rhodes, an employee representative, of Ketchikan, is a 23-year member of the International Brotherhood of Electrical Workers Union Local 1547. He served as a member for labor on the Board from August 2001 until March 2005. He was appointed by Governor Sean Parnell to a four-year term as Commissioner in February 2012, and was reappointed to a 5-year term by Governor Bill Walker in January 2016. His term expires on March 1, 2021.

**S. T. Hagedorn, an employer representative**, of Anchorage, retired from the Alaska Railroad Corporation in

June 2009 after a 34-year career, with the last 24 years as Corporate Risk Manager. He was appointed as a member for industry to the Board in 1991 by Governor Walter Hickel, reappointed twice by Governor Tony Knowles, and reappointed in 2006 by Governor Frank Murkowski (15 years of Board service). He has a B.A. in history from the University of Northern He was appointed by Governor lowa. Sarah Palin to a five-year term as in March 2007. Commissioner reappointed by Governor Sean Parnell to another five-year term in February 2012; and reappointed by Governor Bill Walker to an additional five-year term in February 2017. His term expires on March 1, 2022.


Michael J. Notar, an employee representative, of Juneau, appointed as Commissioner in September 2015 by Governor Bill Walker, and reappointed by Governor Bill Walker to a five-year term on January 4, 2018. After graduating high school in 1970 and a brief stint in college, he started his working career as a Surveyor with the State of Alaska in 1971. He also worked as a Teamster Surveyor before joining the International Brotherhood of Electrical Workers (IBEW) Local 1547 in 1977, where he worked as an Apprentice Flectrician and Communications Technician. He was appointed in 1995 to the IBEW Local 1547 Assistant Business Manager position in Juneau, where he served for 15 years. He returned to State of Alaska service in 2010 at the Department of Labor and Workforce Development and served as a Wage and Hour Investigator, Special Assistant to the Commissioner, and Southeast Wage & Hour Supervising Investigator. He retired from active employment in 2013 and is a lifelong Alaskan. His term expires on March 1, 2023.

#### **COMMISSION CASES**

#### Cases Filed in 2017

The Commission docketed 26 new cases in 2017, an increase of 6 from the number of new cases filed in 2016. Figure 2 shows the types of cases filed in 2017.

#### **2017 Commission Docket**

There was a total of 43 cases on the Commission's 2017 docket, a decrease of 2 cases from 2016.

In addition to the 26 new cases filed in 2017, the Commission began 2017 with 16 cases on its docket: 2 filed in 2014, 2 filed in 2015, and 12 filed in 2016.

Both of the 2014 cases were still on the docket at the beginning of 2017 due to having been remanded to the Commission by the Alaska Supreme Court in late 2016.

One 2015 case was still on the docket due to having been filed in late 2015 and oral argument having been scheduled in late 2016. The second 2015 case was still on the docket due to having been filed in late 2015 and stayed in 2016 pending further Board action. The Board issued a decision in 2017 which was then appealed to the Commission.

Another 2014 case came back on the docket due to an Alaska Supreme Court remand. Figure 3 compares the number of cases on the 2016 docket with the number of cases on the 2017 docket.

At the end of 2017, the Commission had 19 cases on its docket. One case filed in late 2015 was stayed in 2016 pending further Board action and the Board decision issued in 2017 was appealed to the Commission. A decision was issued in January 2018 for one case filed in late 2016. The remaining 17 cases were filed in 2017.

Figure 4 shows the number of open cases on the Commission docket at the end of each month during 2017, as well as new cases filed, oral arguments and hearings held, published final decisions, published memorandum decisions, and unpublished orders issued during each month.

Appendix A is the Commission's complete 2017 docket and contains data for each case such as date filed, type of case, attorney representation, results of

Commission action, and any action taken at the Alaska Supreme Court.

Appendix A also includes cases from prior calendar years that are currently on appeal or petition for review before the Alaska Supreme Court, as well as cases from prior calendar years that were remanded to the Commission for further action in 2017.

### <u>Oral Arguments, Hearings, and</u> Orders

The Commission held 16 hearings in 2017, 7 more than were held in 2016: 9 oral arguments on appeal, 1 oral argument on a petition for review, and 6 hearings on motions for stays of Board orders. Oral argument was not requested in some appeals and those were decided on the record and written briefs. Figure 5 compares the number and types of hearings held by the Commission in 2017 with the number and types held in 2016.

The Commission issued unpublished orders on motions for extensions of time to file appeals, stays pending appeal, dismissals, waivers of filing fees and/or transcript costs, attorney fees, stays of appeals, reconsideration, clarification, and granting or denying petitions for review. The Commission Chair issued orders on procedural matters such as motions for extensions of time and notices of default with orders to comply. In 2017, the Commission issued a total of

113 unpublished orders, an increase of 31 unpublished orders, or 27%, from 2016.

# Average Time Period for Cases Closed in 2017

#### All Cases Closed in 2017

Of the 43 cases that appeared on the Commission's 2017 docket, 24 were closed in 2017. This is a closure rate of 56% of the total number of cases that appeared on the 2017 docket, a decrease of 8% from the 2016 closure rate for all cases closed. The average time period from the date of filing to the date of closure for those 24 cases was 184 days, a decrease of 42 days from the 2016 average time period, and well under the Commission's target of processing cases within 360 days.

#### All Cases Filed and Closed in 2017

Nine of the 26 cases filed in 2017 were also closed in 2017, a closure rate of 35% for cases both filed and closed in the 2017. This is a decrease of 5% from the 2016 closure rate for cases both filed and closed in the same year.

The average time period from the date of filing to the date of closure for cases that were both filed and closed in 2017 was 85 days. This is a decrease of 38

days from the 2016 average time period from the date of filing to the date of closure for cases that were both filed and closed in 2016.

#### **Resolution of Cases in 2017**

Of the 24 cases on the 2017 docket that were closed, 9 resulted in decisions on the merits of appeals (1 decision was for 2 cases that were consolidated prior to oral argument); 2 resulted in orders on remand after Alaska Supreme Court remands; 5 settled; 3 were dismissed for failure to prosecute; 2 petitions for review were denied; 1 petition for review resulted in a decision, and 2 motions for extensions of time to file appeals were denied. (See Appendix A.).

### **Indigent Participants**

In 2017, 2 unrepresented employees filed motions to waive payment of both the filing fee and transcript cost, both of which were granted. One unrepresented employee paid the filing fee and filed a motion to waive payment of the transcript cost, which was granted. In 2017, the Commission paid \$1,338.00 to have Board hearing recordings transcribed for indigent employees. Of that amount,

\$576.00 was for a fourth unrepresented employee whose motion to waive the transcript cost was granted in late 2016, but the invoice was received and paid in early 2017.

#### **Attorney Representation**

#### **Employees**


Employees filed 17 of the 26 new cases in 2017, with 9 of those filed by unrepresented employees and remaining filed by represented employees. In the cases filed by unrepresented employees, all opposing parties were represented. In 7 cases filed by represented employees, all opposing parties were represented. In 1 case filed by a represented employee, the Workers' Compensation Benefits Guaranty Fund was represented and the employer did not participate.

#### **Employers**

Represented employers filed 9 cases. In 5 cases of those cases the employee was represented, and in 3 cases the employee was unrepresented. One case was filed by a represented uninsured employer and no employee was involved. No cases were filed by an unrepresented employer.

Figure 10 compares unrepresented and represented participants. When compared to 2016, the number of cases filed by unrepresented employees increased by 1 and the number of cases filed by represented employees remained the same. The number of cases filed by represented employers increased by 5 and the number of cases filed by unrepresented employers remained the same.

#### **COMMISSION DECISIONS**

#### **Published Decisions**

In 2017, 10 Commission decisions were published. Eight were final decisions on the merits of appeals (1 of which was for 2 appeals that had been consolidated prior to oral argument), 1 was a memorandum decision on a petition for review, and 1 was a memorandum decision on a motion for a stay of a Board Appendix B is the list of the order. Commission's 2017 published decisions, with notes on the number of days from filing to issuance of a final decision on the merits of the appeal, the number of days from oral argument or record closure to issuance of a final decision on the merits appeal, and whether of the Commission's decision was appealed or petitioned for review to the Alaska Supreme Court.

In the 8 cases where a final decision on the merits of the appeal was issued in 2017, the average time from oral argument or record closure to the issuance of the final decision was 63 days, 27 days less than the statutory allowance of 90 days.

## <u>Time Period Between Initial</u> <u>Receipt and Decision on Appeal</u>

The Commission's target is to process cases within 360 days from initial receipt. As shown in Figure 11 below, the timeline for an appeal is approximately 255 days if there are no extensions of time or stays of appeal proceedings. One reason appeal proceedings may be stayed would be for settlement negotiations.

As shown in Appendix B, the average time period between the initial receipt of an appeal and the issuance of a final decision on the merits of the appeal for cases on the 2017 docket was 268 days. This is 79 fewer days than the 2016 average, and well under the Commission's target of processing cases within 360 days.

One case listed in Appendix B took 449 days to process due to it being filed as a petition for review and then converted to an appeal, and the granting of several extensions of time.

## <u>Published Decisions – Case</u> Resolution

The results of Commission decisions published in 2017 are summarized in Appendix B. Of the 8 published final decisions issued on the merits of appeals of Board decisions, 5 affirmed the Board's

decision; 1 affirmed in part, reversed in part, and remanded to the Board; 1 affirmed in part, modified in part, and remanded to the Board; and 1 remanded to the Board.

The Commission published 1 memorandum decision on a motion for stay of a Board decision, and 1 memorandum decision denying a petition for review of an interlocutory Board decision in 2017.

The Commission received 6 petitions for review in 2017; 1 was granted, 2 were denied, 1 settled, 1 was converted to an appeal, and 1 is currently pending. The Commission does not consider the granting or denial of a petition for review to be a decision on the merits of the challenged Board decision.

# ALASKA SUPREME COURT ACTION

Three Commission decisions issued in 2017 were appealed to the Alaska Supreme Court and 1 was petitioned for review, all of which are currently awaiting rulings. *See* Appendix A.

In addition, 3 Commission orders issued in 2017 were appealed to the Alaska Supreme Court and 2 were petitioned for review, all of which are currently awaiting rulings. *See* Appendix A.

A total of 12 Commission decisions or orders presently await Alaska Supreme Court rulings: 1 issued in 2015, 2 issued in 2016, and 9 issued in 2017. *See* Appendix A to see which decisions and orders await rulings.

In 2017, the Alaska Supreme Court decided 2 appeals of Commission decisions. The Alaska Supreme Court

issued 1 memorandum opinion and judgment which does not create legal precedent and 1 opinion creating legal precedent.

The Alaska Supreme Court issued Memorandum Opinion and Judgment No. 1643 on July 19, 2017, in a 2014 appeal, *Rosales v. Icicle Seafoods, Inc.*, which affirmed the Commission's decision which had affirmed the Board's decision.

The Alaska Supreme Court issued an opinion on August 25, 2017, in a 2014 appeal, *Alaska Airlines, Inc. v. Darrow,* 403 P.3d 1116, which affirmed in part, reversed in part, and remanded the Commission's decision, which had reversed in part and affirmed in part the Board's decision.

#### REGULATION CHANGES

No changes were made to the Commission's regulations during 2017.
