Requirements:

- ❖ All potential applicants will be required to participate in a Physical Abilities Job Demonstration. You must pass this demonstration to be considered as an applicant.
- ❖ You must be at least 18 years of age, be able to lift 75 lbs. and have the ability to maneuver any weight above 75lbs. with the proper equipment and/or assistance from another person.
- ❖ High School Diploma or GED. If obtained in the last five years, we will need to see original document or transcripts.
- ❖ FedEx is a drug-free workplace. All applicants will be subjected to a UDS (Urinary Drug Screening) prior to employment.
- ❖ Based on USPS Clearance requirements, you must have resided in the United States for the past 5 consecutive years.
